- > The notional Stipend Figure (Mercer Beneficiary Fund) for 2023-2024 is \$65,402 annually.
- > All levies are to be paid by the Congregation/Appointing Body to Synod Finance on a monthly basis.
- > Congregation/Appointing Body Beneficiary Fund contribution will be paid monthly based on the standard rate of 11 % unless the agreed taxable remuneration is less than \$450 a month.



> Minister's personal Beneficiary Fund contribution transferred by Congregation/Appointing Body will be paid monthly into the nominated fund.
